Private Boat Storage Application and Agreement, page 2

A. Rowing Guidelines, including rowing under cold water conditions (October 15 to June 14, or when the water temperature is below 15 °C).

Check 1. OR 2. below:

1. I agree to abide by all the current rules, including cold-water rules, outlined in the BRC Safety Program posted on www.barrierowing.org.
2. I reserve the right to row my private shell without a coach/safety boat, with or without a buddy boat, including during cold water conditions.

If you checked No. 2 above, please complete the following section:

- a. I am 18+ and I have discussed my desire to row without support with my spouse/significant other/parent or guardian, and s/he has signed this application and agreed not to pursue action against the Barrie Rowing Club, its Directors, consultants, or contractors in the event of my experiencing injury or death.
- b. I acknowledge that I have read and understand the BRC Safety infographic document “Understanding Cold Weather” posted in the boathouse and included as an appendix in the BRC Safety Program document. I am aware that in the event of capsizing or other event that leaves me in water below 15 °C, my chances of survival are limited.

B. Recommendations:

The Barrie Rowing Club highly recommends that you

- ❖ establish a monitoring system (i.e. satellite alert, notify someone prior to and upon returning from each trip, etc) to respond in the event that you do not return at the expected time; and
- ❖ demonstrate the ability to re-enter your shell in all water conditions. If you have already done so, please

C. Terms and Conditions (excerpts):

(For complete Terms and Conditions, refer to the document “Private Boat Storage Policy” posted on www.barrierowing.org):

1. The Barrie Rowing Club (BRC) makes space available for full members in good standing to store privately owned boats for the purpose of rowing. Articles that can be stored under this storage agreement include one boat, one set of blades and rigging.
2. A member in good standing is defined as a member who abides by the rules/policies established by the BRC and the Private Boat Storage Committee (PBSC) and has paid both the applicable full membership fee and storage fee, or arranged a payment plan, either before going on the water or no later than May 1st, whichever comes first.
3. The assignment of specific space/rack/sling is at the discretion of the PBSC. In addition, the PBSC and BRC reserve the right to move, relocate or remove any privately owned boat (see details in the Private Boat Storage Policy).
4. Private boat owners store their boat/equipment at their own risk. The Club does not assume responsibility for damage, loss or theft involving members’ boats/equipment stored at the Club’s premises. It is the sole responsibility of the private boat owner to obtain appropriate insurance protection and follow the BRC safety rules.
5. Private boat owners wishing to discontinue occupancy of their space/rack/sling should notify the PBSC, preferably in writing, as soon as possible. With regards to the upcoming season, notice should be given before May 1st and the shell removed as soon as possible. Membership and storage fees will apply for the time the boat is on the racks.
6. All private boat owners will complete and sign this Private Boat Storage Application and Agreement which includes a description of the equipment stored and a list of authorized users. This agreement will remain valid for as long as the private boat owner is in good standing.
